Zurich platziert erfolgreich vorrangige Anleihe in Höhe von AUD 350 Millionen

Zürich, 24. Mai 2018 – Zurich Insurance Group (Zurich) hat heute die erfolgreiche Platzierung einer vorrangigen Anleihe in Höhe von AUD 350 Millionen („Anleihe“) bekannt gegeben. Die Anleihe hat eine Laufzeit bis Mai 2023. Die Transaktion richtete sich an australische und asiatische Investoren.

Die Anleihe wird von Zurich Finance (Australia) Limited ausgegeben und hat einen Coupon von 3,477%.

Die Transaktion wurde für allgemeine geschäftliche Zwecke durchgeführt.

Zurich Insurance Group (Zurich) ist eine führende Mehrspartenversicherung, die Dienstleistungen für Kunden in globalen und lokalen Märkten erbringt. Mit rund 53'000 Mitarbeitenden bietet Zurich eine umfassende Palette von Produkten und Dienstleistungen im Schaden- und Unfall- sowie im Lebensversicherungsbereich. Zu ihren Kunden gehören Einzelpersonen, kleine, mittlere und grosse Unternehmen sowie multinationale Konzerne in mehr als 210 Ländern und Gebieten. Die Gruppe hat ihren Hauptsitz in Zürich, Schweiz, wo sie 1872 gegründet wurde. Die Holdinggesellschaft, die Zurich Insurance Group AG (ZURN), ist an der SIX Swiss Exchange kotiert und verfügt über ein Level I American Depositary Receipt Programm (ZURVY), das ausserbörslich an der OTCQX gehandelt wird.
