

Mario Greco receives prestigious Insurance Leader of the Year Award

Mr. Greco also announced a USD 500,000 donation to extend the Zurich Fellows scholarship program for graduate studies, which was launched in 2020, and to establish the Center of Middle Market Risk Management Excellence.
